Division 7 Building Contractors shall furnish all necessary materials, labor, equipment, & supervision to implement:

Firestone EPDM 60-Mil Membrane Roofing System according to all published procedures by the roof system manufacturer. This work shall be performed consistent with 20-year durability standards for warrantability and implemented directly by Division 7 as a Firestone licensed applicator with Master Contractor status.

Building Two

The following scope of work is included in the project price for Building Two to encapsulate any asbestos containing materials and provide a fully waterproof roof system:

Tear Off & Deck Replacement

Tear Off and Deck Replacement for areas of roof deemed by Division 7 to be unsuitable for implementation of roofing membrane under 20 year durability standards. The deck replacement, if any, will use the specialty lumber specified by the building owner and be billed at unit prices. Includes removal of one smoke stack unit at West End of building.

Vapor Barrier

Implement Firestone Self Adhered Vapor Barrier over replaced decking, if any, using adhesion or mechanical fastening if weather conditions do not permit adhering.

Membrane

Implement Firestone Reinforced 60-Mil Black EPDM using mechanical fastening consistent with 20-year durability warranty standards.

Penetrations & Flashings

Install all necessary membrane flashings at perimeters and penetrations for rooftop units and pipe protrusions. Drains on south side shall be decked over due to implementation of gutter and demolition of adjacent building, consistent with Prior Agreement.

Metal/Gutter

Custom fabrication and installation of gutter system and downspouts for water runoff in standard color.

Building Three

The following scope of work is included in the project price for Building Three to encapsulate any asbestos containing materials and provide a fully waterproof roof system:

Estimated Start Date

Roof system installation shall start at the direction of the customer, dependent on weather and other trades.

Estimated Duration

Roof system installation requires approximately fifteen working days, contingent on weather and other trades. There is a high probability of variability in this duration due to unique site conditions.



Warranty Provisions

Base Provisions

Division 7 Building Contractors, in combination with the manufacturer of the membrane and materials used in the installation the proposed roof system, will warrant to the building owner warranty coverage for the repair of any leak that occurs within the total system. The specific terms of these coverages are available upon request.

- Repair coverage does not depreciate or otherwise reduce as time goes on
- Repair coverage includes materials and labor without any limits on dollar amount
- Coverage encompasses any defect in materials or workmanship in the installation of materials
- The total system includes the Membrane, Flashings, Adhesives, Sealants, Insulation, Coverboards, Fasteners, Fastener Plates, Fastening Bars, Metal Work, and any other manufacturer products used during installation.

Included Duration: 20 YEAR TOTAL SYSTEM WARRANTY
NO DEDUCTIBLE, NO DEPRECIATION, NO DOLLAR LIMIT

Exclusions

Warranty coverage does not cover damage resulting from:

- Natural disasters such as lightning, fire, insect infestations, earthquakes, tornadoes, hurricanes, or the like.
- Intentional or negligent acts of vandalism, accidents, misuse, abuse, civil disobedience, or the like.
- Deterioration or failure of building structure or building components such as walls, roof top units, etc.
- Acids, oils, chemicals or other harmful substances which come in contact with the roof after installation.
- Leaks caused by adjacent walls or which were not repaired/replaced at time of installation.



Notes & Clarifications

Standard Terms

The following terms and conditions apply to this proposal.

- 1. This proposal does not include the cost of permits, bonds, engineering calculations or seals.
- 4. For re-roof projects, watertight night seals are included for each tie-in to existing roof while work is ongoing.
- 5. Temporary roofs, tarping or the like is not included unless explicitly specified in applicable bid section.
- 6. Snow removal, wood blocking, or roof hatches are not included unless specified in applicable bid section.
- 7. Pricing based on standard stock color for metal components; custom color choice may result in price increase.
- 8. Due to asbestos encapsulation the productivity rate is anticipated to be slower.
- 9. Fabrication and/or installation of curbs to support rooftop units is not included.

Clarifications

The following clarifications are provided regarding this proposal. Should the customer elect to award Division 7 Building Contractors the proposed work, acceptance of the award shall be contingent on mutual agreement of the following terms:

- 1. An award notification by the customer shall not be considered a contract until countersigned by an officer of Division 7 Building Contractors, Inc. and the customer shall have no basis for any claim unless a mutually executed contract is in place.

("D7BCI") is capable of satisfying the deadlines documented in the original bid package, however, D7BCI shall not be liable, in any capacity or manner, for any damages, including liquidated damages, for any construction delay(s) which are the result of other trades.

- 2. Coverboard up to ¼" will be provided as needed on a unit cost basis of \$1.37/SF, including all labor, fasteners and adhesives as required to achieve 20 year warrantability.
