Love Your Hometown Grant – from the Allegan County Community Foundation - there was discussion about how to use the money. Bunny mentioned that she has been asked about the Boy and Girl under the Umbrella statue that used to be in front of City Hall not that many years ago. It was removed due to the damage it was suffering from the elements and has been safely stored away. Bunny suggested a shelter for the statue so it can be displayed again maybe in Hicks Park. The cost would probably be greater than the \$1,000 available. Another suggestion was made regarding the flower baskets and need for irrigation on the M-89 bridge on Allegan Street; also, some way to improve the aesthetic of that portion of the road into Plainwell. There was talk about the old roses along the fence which were beautiful, but disappeared while in Bankruptcy. Bunny suggested some "knock-out" roses along the fences to help beautify that section of Allegan Street. A decision was made to write the grant for the aesthetic improvement of M-89 with irrigation on the bridge for future flower planters and the roses along the fence. They will seek approval from Erik Wilson and speak to Denise Siegel about writing the grant. Bunny volunteered to write the grant if Denise is unavailable.
